Group contributions for November were \$1,270.00. December contributions of \$101.20 and expenses totaled \$56.75.

No money spent on literature this year but \$700 was budgeted and not used. A larger than normal literature expense may be anticipated for 2017. The intergroup usually gets the literature and encourages groups to buy from them in order to save on shipping which is expensive. Vice chair used to take care of literature.
